Regular association meetings are held the first Thursday of every month at 7pm.

You must be sponsored by a current member in good standing. For Junior membership, only a parent or legal guardian who is a current member in good standing may be a sponsor.

Complete the application form in full using black ink. Print clearly. Your application must be notarized.

Your sponsor may submit your application at a regular monthly meeting, you need not be present. Your application places you on a waiting list where consideration is based on annual membership renewals. Our current membership is limited to 275 members. You will be notified by a member of our investigation committee to discuss your application and to meet for an interview. The process takes approximately 60 days from the time we receive your application to approval by membership.

You must attend a New Member Orientation within one (1) month of being inducted into membership. The purpose of the New Member Orientation is to go over our by-laws, policies, safety procedures, range rules and property. You will have a photo taken for your member ID card. If you fail to complete the mandatory New Member Orientation within one (1) month of being inducted, your membership will be revoked. If your membership is revoked, you will receive a refund minus \$50.

You will be on probation for one year (12 months) from the date you are inducted. Your first renewal is subject to Board approval.

All members are required to attend 4 monthly meetings and perform 8 hours of work duties throughout the year.

All members are subject to disciplinary action by the Board of Directors for violation of club rules and policies.
